The stage has arrived on our campus when some persons in exercising their asserted freedoms are creating conditions which infringe on the freedoms of others. The University staff is striving to protect freedom and security of person and property for the whole University community, but this is especially difficult at night. In order that the sources of the nightly incidents of rock tossing, window breaking, gasoline bombing, and paint throwing may be pinpointed, I ask all students and faculty to remain off the open campus from midnight until 6:00 a.m. each night until the end of this semester. By cooperating you will assist the University in maintaining a campus open to all essential educational functions.

TOWN OF NORMAL

The Town of Normal, in cooperation with Illinois State University, has proclaimed that a curfew applicable to all individuals within the community will prevail from midnight to 6:00 a.m., effective immediately. This curfew is applicable throughout the Town of Normal and including the campus of Illinois State University. All property of the University, including the University Farm, is a part of the Town of Normal.

Students arrested for curfew violation may be subject to University discipline with resultant jeopardy of educational benefits.

Members of the University faculty and staff are assuming internal control of all University buildings for the duration of the curfew from 10:00 pm. each night through 6:00 a.m. of the following day. Anyone having need to be in one of the campus buildings during those hours should be prepared to present identification and reasons for presence in the building. University residence halls remain under the complete jurisdiction of the staff of the Dean of Student Services assigned to those areas.

BUILDINGS TO BE STAFFED

10 p.m. to 6 a.m.
Curfew 12 midnight to 6 a.m.

- 1. Be polite but firm. Use good judgment.
- 2. No less than two people on duty at all times.
- 3. Carry a pencil and pad for logging purposes.
- 4. You are only responsible for the interior of the building. If movement is seen outside building, notify building supervisor. If necessary he will call Security (8-2108). Do not attempt to investigate.
- 5. Building will be secured at 12 midnight or before if all regular activities are terminated.
- 6. Building should be toured periodically no less than every hour. Tour in pairs, not alone.
- 7. Please do not gather in groups.
- 8. Stay within assigned area.
- 9. If an employee finds it necessary to enter building, do not unlock door until person is identified. Do not allow admission until he has logged in -- time and destination. Instruct visitor to building to notify building lieutenant when he leaves so they may be logged out.
- 10. Notify building lieutenant if there are any violations to the above or if there is refusal to cooperate.
- 11. Do not try to be a hero.
